
Buffalo Gap I&E places great value on driving safety and strives to give employees the support, knowledge, training, and time to make driving safety a key value at work, home, and play.

Through the traffic safety efforts implemented, the City reduced the number of auto liability incidents by 13% and reduced its claim costs by 36% from fiscal year 2015 to fiscal vear 2016.

Dallas ISD Risk Management has sound policies in place that structure their Driver Safety Program, including a cell phone use policy prohibiting the use of cell phones, both hand-held and hands-free, while driving a district vehicle. Training focuses on safe driving topics that can be applied to everyday driving.

This past year, the district had the lowest costs in four years and lower at-fault incidents than the previous year. A driver

with safe driving habits on the job will also be a driver with safe driving habits while off the job.

MedStar Mobile Healthcare

With a fleet of nearly 60 ambulances and 10 support vehicles, it is imperative to train, monitor behavioral drift, and set high standards for those who drive a MedStar vehicle.

With a large Millennial work force, MedStar evolved their training and education to maintain desired results and engagement. Common classroom training, cones courses, and field training officers were added to sustain desired behaviors and expand the education to all employees, even non-drivers.

MedStar recognized they have the opportunity to make a significant impact on team member's driving behavior. MedStar also recognized that through effective training and education, they can improve not just the employee's safety, but the safety of their families and the community around them by teaching safe driving habits.

The City of Irving alone has 1,683 fulltime employees and operates more than 800 vehicles. There is no doubt that time and money can be saved with focusing on traffic safety education, but most importantly, lives can be saved.

Traffic safety education is critical to assuring that Irving residents, businesses, visitors, and employees are safe within the borders of their city. The City of Irving has maintained an emphasis on reducing crashes that result in injuries and fatalities by gaining compliance and driver responsibility through education, engineering, and enforcement.

City of San Antonio

The City of San Antonio has 12,000 employees and a vehicle fleet pool upwards of 5,144. Traffic safety education is essential and a top priority.

The Safety Program is comprised of comprehensive training in primary driver roles and responsibilities, as well as reasonable suspicion training for supervisors and managers at all levels. Training included 143 sessions with 4,181 employees trained. Staff conducted 43 NSC-sanctioned Defensive Driving Courses and two NSC Professional Truck Driving Classes.

With the City Manager's endorsement and executive support in establishing a zero preventable safety initiative in incidents and injuries, the City is well on its way in establishing a culture of safety for employees, contractors, and the public.

City of Waco

The City of Waco has high expectation in all forms of safety for city employees and works to ensure City employees are educated, safe, and responsible to do their part in making sure they are safe drivers.

Safety Officers in each department attended the NSC Our **Driving Concern** program. The officers provide on-going safety education to employees, which keeps traffic safety in front of employees year round. In-house NSC-certified Defensive Driving Instructors provide the six-hour training sessions, and offer an on-line option, too. The use of seat belts and no use of cell phones when operating vehicles is required.

Over the past few years traffic safety has increasingly become a greater part of the city-wide education process for City employees, and the benefits are obvious as trends indicate their driving-related incidents are decreasing.

Employee education includes DDC, posters, paycheck inserts, and monthly safety meetings about the hazards of distracted driving and driving impaired. Employees are provided a ride home if they ever feel like they are unable to drive for any reason. All employees sign a distracted driving and cell phone (texting/calling) policy.

Employees are not allowed to use the phone to conduct company or personal business while driving a company vehicle. This policy has been LeMeilleur's most effective way to eliminate distracted driving, and is shared with customers and employees' families.

Recognizing that over 50% of the Port's employees operate Port vehicles as a function of their job duties, they developed a plan for employee traffic safety education, with an emphasis on distracted driving. Three individuals completed the **Our Driving Concern** (ODC) Train the Trainer workshop. Their experience became a part of the Port's employee traffic safety plan, beginning with the highest risk departments first.
